6 Injury and Indemnification

If Pet Owner's pet(s) accidentally dies, becomes ill, injured, or lost, Pet Owner waives and releases Groom n' Board LLC from any claim arising from such an incident. If Pet Owner's pet(s) bites or injures Groom n' Board LLC, any other human or animal, Pet Owner will be responsible for any resulting injury and shall hold harmless and indemnify Groom n' Board LLC from any claim or suit that may be brought as a result of such an incident. In addition, Pet Owner shall hold harmless and indemnify Groom n' Board LLC against any and all costs, expenses, losses, liabilities and claims arising out of or relating to any acts of Pet Owner's pet(s) except for negligence or intentional misconduct on the part of Groom n' Board LLC.

a. Pet owner understands that Groom n' Board LLC will do everything to ensure the safety and comfort of the pet while in the care of Groom n' Board LLC.

b. Grooming of pets can sometimes be a stressful event for pets and the Pet Owner understands that during certain processes (de-matting, ear cleaning, nail trimming etc...), pets can become anxious and sometimes experience discomfort. Groom n' Board LLC will strive to keep pet as comfortable as possible and in certain cases may need to abort the grooming process if pet becomes overly unruly or experiences excessive discomfort.

c. Removing excessive matting on a pet can be very painful for pet and in some cases, the coat may need to be shaved. Groom n' Board LLC will do everything possible to avoid the discomfort of the pet and in cases where the coat needs to be shaved, will only proceed with the consent of owner.

7 Governing Law

The terms of this Agreement shall be governed by and construed in accordance with the laws of the State of Florida, not including its conflicts of law provisions.

8 Severability

If any provision of this Agreement is held to be invalid or unenforceable in whole or in part, the remaining provisions shall not be affected and shall continue to be valid and enforceable as though the invalid or unenforceable parts had not been included in this Agreement.

9 Entire Agreement and Amendment

This Agreement contains the entire understanding between the Parties and supersedes and cancels all prior agreements of the Parties. This Agreement may be amended or modified only by a written agreement signed by all the Parties.

This agreement shall be upheld for all future interactions between "Pet Owner" and Groom n' Board LLC. The dates mentioned on page 1 reflect the initial stay, however, all terms are binding for all future boarding and grooming of "Pet Owner's" pet
